### **Phase II of Baltimore City's Snow Emergency Plan to be Lifted on Saturday at Noon**

Declaration of Local State of Emergency Also Ends

The Baltimore City Department of Transportation would like to advise motorists that Phase II of the Snow Emergency Plan will be **lifted at 12:00 p.m. Saturday, January 30, 2016** in Baltimore City. Once Phase II is lifted, citizens will be able to resume parking along designated snow emergency routes. **Effective at this time, Mayor Rawlings-Blake is also ending her declaration of a local state of emergency.**

**As of 7:00 p.m. today, 99% of all city streets are passable for motorists** Throughout the weekend, snow crews will continue removal operations. Citizens whose streets are not passable at this time should call 311 or use the 311 application to request service.

Snow removal efforts will be focused in city neighborhoods and along major gateways to remove piles of snow and clear parking/travel lanes as we prepare for schools to reopen on Monday. Citizens who utilized parking at designated city school lots during the Phase II emergency should remove their vehicles by **6:00 p.m. on Sunday, January 31, 2016.**

The Department of Transportation would like to extend a special thanks to all of our snow crews, local contractors and out of state forces that have worked diligently around the clock helping Baltimore City recover from this historical storm. Over 240 million pounds of snow have been hauled from city streets throughout the week, with operations continuing.

We also want to thank the citizens of Baltimore for their patience and support as we worked to clear city streets after ‘Winter Storm Jonas’.
